Tenderer's must have minimum specific experience as a prime contractor or management contractor in a single work order and under a single contract, that have been successfully completed and handed over and that are similar to the proposed works, in supply & installation of at least 2(Two) contracts successfully completed within the last 5 (five) years, with a value at least TK.5 (Five) / 1.5 crore (For AC & Fire) respectively of each contract under any Govt./semi govt/autonomous organization / Any Bank and any Insurance company only. The similarity shall be based on the physical size, complexity, methods/technology or other characteristics as described in BOQ/Scope of works of tender document. Tenderer must have at least 10(ten) years (As per certificate of Incorporation) overall experience for successfully completion of supply, installation, testing and commissioning of similar nature Fire Fighting and Central Air Conditioning system with USA/Japan/European manufactured chillers and related services as a prime contractor/management contractor under any govt. / semi govt. / autonomous organization / any bank / any insurance company only. The years counting backward from the date of publication of IFT in the daily newspaper.
