1. What is the Mastercard Save. Spend. Win. campaign with Foodi?

3. How can I participate?

To participate:

- Save your Mastercard Debit, Credit, or Prepaid Card on the Foodi app.
- Use the saved Mastercard to make purchases on Foodi during the campaign period.
- Every successful Mastercard transaction will be counted toward the campaign.

4. What rewards can I win?

The top five customers with the highest number of successful Mastercard transactions on Foodi during the campaign period will receive the following rewards:
